Geoff Bardwell holds a PhD in Women's Studies and Feminist Research from the University of Western Ontario, where he examined how LGBTQ community is defined and sustained in a mid-sized Canadian city. He is currently a postdoctoral research fellow in the Department of Medicine at the University of British Columbia, where his research focuses on substance use and how intersections of identities and experiences (e.g., gender, sexuality, ethnicity) as well as social, structural, and physical environments (e.g., stigma, criminalization, and drug use spaces), produce varying conditions of vulnerability, marginalization, and risk for people who use drugs. Dr. Bardwell is supported by a Mitacs Elevate Postdoctoral Fellowship from Mitacs Canada.
